## Summary

## Part 1: Collections

### Journals

The library invests heavily in providing access to online journals. Currently, the library subscribes to approximately 55,000 online journals, most of which are discoverable at the article level through the Omni search interface, and through many discipline-specific abstracting and indexing databases. The library subscribes to nearly complete collections of journals from all major scholarly publishers, including SAGE, Taylor & Francis, Oxford University Press, Cambridge University Press, the American Psychological Association, Wiley, Springer, and Elsevier.

The university has access to most of the relevant high impact factor journals, according to Clarivate's *Journal Citation Reports (JCR)* database (2018).

### Books and E-Books

Based on a review of political science coverage across our automated book purchasing tools, the library has undertaken improvements to expand collections in the areas of Latin American politics and international relations, to provide more comprehensive book coverage in these core subject areas. Wherever possible, the library preferences e-books that are free from digital locks (Digital Rights Management technology) to ensure unfettered access and use.

Many new titles were purchased in support of recent course proposals from the political science department, and the library maintains close communication with faculty to ensure that individual title requests are received and purchased as needed.

While the Library continues to purchase many print books, the acquisition of e-books is increasing. E-books facilitate point-of-need and remote access to books. E-book chapters are also used in the campus learning management system.

## Part 2: Academic and Professional Skills

### Student Consultations (aggregate; not limited to political science students)

Library staff provided more than 8,000 individual consultations to students in 2018-19. Students receive expert support on a range of academic and professional skills in research, learning, studying and writing.

### Research and Information Literacy (IL) Skills

Information Literacy (IL) librarians prioritize support to large, required, and core courses that have research skills or digital media literacy assignments or components. IL librarians aim to scaffold their information literacy instruction throughout the required curriculum, providing students with the opportunity to build on their skills year over year. Options for supporting students include:

### Learning Services

Learning Specialists support students' academic skill development through:

- working with faculty to develop assignments, assessment and in-class workshops (critical reading, working in groups, presentation skills, poster presentations, and exam preparation), customized student resources (such as an error analysis worksheet for midterms)
- co-curricular programming, including workshops - Graduate programming, including Brain Food (thesis management), Presentation Boot Camp, and Graduate on Time (time and project management)

In 2013, at the request of a Political Science faculty member, Learning Services staff developed a workshop on critical and strategic reading strategies for graduate students. This workshop has now run in that course every fall semester. In addition, this partnership helped Learning Services expand its support for students by providing reading-related workshops (years have varied) in POLS\*1500, POLS\*4300, POLS\*4710, POLS\*4930, and courses in other colleges.
